
Geographically, the company is focused in the northeastern United States; in jurisdictions that are well known to represent some of the most difficult and complex permitting, development, and construction environments in the nation.

The company is currently active in wide variety of markets, ranging from Florida (to the south) to Maine (to the north) with a concentration throughout the six-state New England area, with a primary focus in metropolitan Boston markets (within the Route # 128 / Route # 95 belt).

During its 20 + year history, through multiple economic cycles and conditions, the company has established a track record of excellence and a reputation for discipline and integrity.

Since its founding in 1990, The Richmond Company, Inc. has developed more than 4.0 million square feet of retail and commercial space and has developed more than twenty-five (25) residential development projects, comprising more than 1,500 dwelling units.

Our retail and commercial projects have focused on grocery-anchored shopping centers, free-standing retail projects, and pad retail projects. Our residential projects have been comprised of single family subdivision projects, townhomes, and multi-family housing communities (including both rental apartment projects and for sale condominiums).






