Dear Members of the Commission:

On behalf of Property Owners/Applicants, Peter and Jennifer Garran, LEC Environmental Consultants, Inc., is submitting this Monitoring Report for the third (2021) growing season, as required under the Amended Order of Conditions Request to Amend the Order of Conditions (NAN-126) originally issued on May 22, 2019. Restoration commenced in May 2019 and LEC has completed monitoring site evaluations during the first (2019) and second (2020) growing seasons.

The restoration area has successfully established as proposed and approved; refer to representative photographs. The restored portions of the Isolated Vegetated Wetlands (IVW's) and Buffer Zones are currently vegetated by a diverse mix of herbaceous vegetation and woody saplings and shrubs, including, but not limited to red maple (*Acer rubrum*), swamp white oak (*Quercus bicolor*), bayberry (*Myrica pensylvanica*), arrowwood (*Viburnum dentatum*), highbush blueberry (*Vaccinium corymbosum*), winterberry (*Ilex verticillata*), and sweet pepperbush (*Clethra alnifolia*). Additional native species, such as groundsel tree (*Baccharis halimifolia*), have also established within the restoration footprint. The perimeter of the lawn/restoration area is defined by rock boulders functioning as permanent markers.

To date, the plantings have met the required survivorship standards over three growing seasons to qualify for filing a Certificate of Compliance Request.
